With the wide experience of more than 40 years handloom textile field and with our dedicate team comprising both local and expertise, we can handle various products from design through production woven fabrics to delivery.

The factory is actually geared to manufacture full woven product range such as Shirt, Dress, Top, Tunic, wedding dress, camisole in both adults and children wear and home textile items such as bags, wall mate, bedspreads, kitchen cloths etc. We have been currently delivering to the various parts of the world such as Asia, Euroup and USA under the GSP mode.

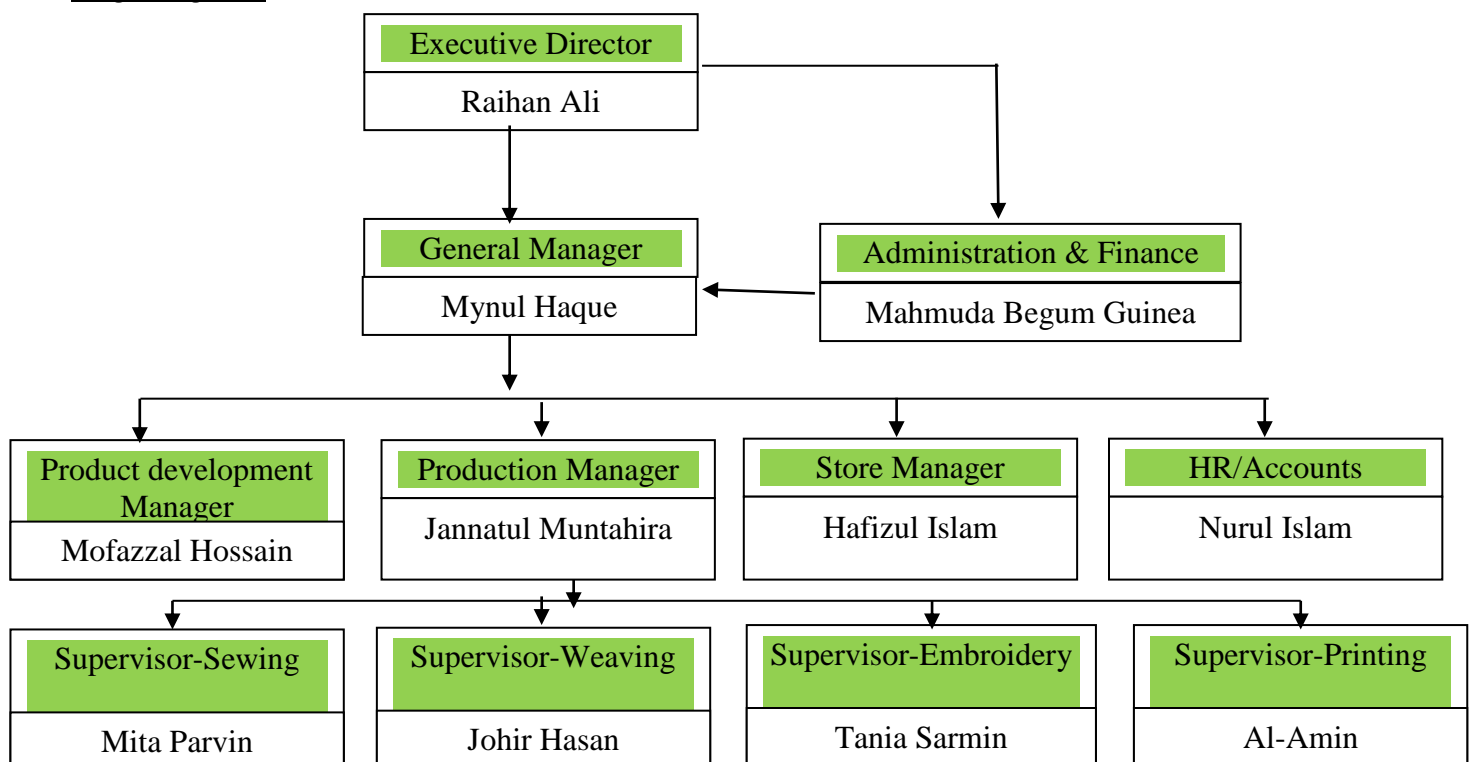

<u>STEP 2</u>	<u>PRICE STUDY, QUATA PROPOSALS AND PRICE VALIDATION</u> <ul style="list-style-type: none"> - <u>Initial indicative delivery plan</u> - <u>Initial planning indicated but fixed at po establishment with changes where applicable. Based on indicative volume to see if customers agrees with proposal to be fine turned at PO.</u> - <u>Inspection mode to be fixed internal or external, who's cost</u>
<u>STEP 3</u>	<u>SAMPLING</u> <ul style="list-style-type: none"> - <u>First sample are payable and reimbursed/ deduct at ordering</u> - <u>Counter samples and PPS done from the bulk fabric after PO confirmation.</u> - <u>Sample dispatched at customer account.</u>
