



Pre-Production Developments

The emphasis of QA prior to the start of production is on the identification of design, quality, safety and product conformity problems at an initial stage when pre-product development is under process.

Product Testing

LMS (Laboratory Management System)

It works as a database from yarn to finished fabric testing data. It helps in correct data analysis and take corrective action accordingly.

Laboratory is fully equipped with latest equipment needed for testing yarn to finished product. Like Raw Material Testing, Intermediate Product Testing, Accessories Testing. Pre-Production Testing and Post Production Testing etc.

Post-production testing is done with complete protocols as per customer specifications.

Internal Inspection Plan

Inline and final inspections are carried out at all production stages with an AQL level of 2.5 and avoid to external inspection is offered till 100% goods are ready and Internal QA has passed those goods.

Separate areas are allocated at all floors to conduct final inspection by Internal and external/ third party QAs.

Once goods are cleared by Internal QA, these are moved directly to finished goods warehouse.
