Application / dose

Apply generously and disperse the cream circa 15 minutes before the exposure to sunlight or UV radiation.

Apply again after intensive contact with water or cleaning agents, after strong sweating or after drying off.

The duration of the protection is 50 times longer than that of untreated skin. It is not extended by repeated application.

Sun screen products can not provide complete protection from UV radiation.

Apply about a teaspoon full of cream for face, neck an ears, for the backs of your hands use a blob about the size of a hazelnut.

Restrictions in use:

Storage instructions:

UV Stop can be stored in closed containers at least for 30 months at a temperature of 5-20 °C. After first use UV Stop is durable for at least 12 months.

Do not store at temperatures over 25 $^{\circ}$ C or exposed to the sun.
