Product certification

Product certification is a tool to emphasize product quality, gain market prominence, and provide a clear guarantee of law requirements-compliant production. IMQ safety and quality trademarks provide three guarantees to Authorities, Customs and purchasers:

the guarantee that the product was manufactured by a company with a production system capable of meeting specific quality standards;

the guarantee that the product passed all the tests necessary to ascertain its conformity with the safety regulations under applicable law before market introduction;

the guarantee that production is subject to a periodical surveillance aimed at verifying that the certified quality standard is maintained.

Conformity to EU directives and regulations

In order to circulate in Europe, industrial products have to demonstrate conformity to the minimum requirements, and in particular safety requirements, defined by specific European directives. For this purpose, IMQ provides technical-regulatory support services to manufacturers and distributors, including:

correct identification and interpretation of the standards applicable to the products and of the tests needed to verify product conformity to applicable requirements;

conducting tests and conformity assessments in order to obtain declarations and certificates of conformity needed to apply CE marking according to the main European directives and regulations.

Main directives and regulations IMQ is notified body for are: • ATEX • automotive • boiler efficiency (BED) • construction product (CPR) • electronic tool (EETS) • EMC • gas appliance (GAR) • lifts • machinery • medical devices (MDR) • MID • RED. Other directives: • automotive • low voltage • energy-related products (ERP) • energy labelling.

Tests and laboratory measurements

IMQ's laboratories (ISO/IEC 17025 accredited) can conduct the following tests: electrical safety, performance and energy efficiency, EMC, radio, lighting, photometry, chemical, environmental, climatic, mechanical, test on equipment intended for use in potentially explosive atmospheres and calibration tests.

Export-import assistance
